Enterovirus type 70 strain J670/71 is propagated in WI-38 cells (ATCC CCL-75). This strain was isolated from the conjuctival scrapings or swabs from patients in Japan with acute hemmorhagic conjunctivitis. This product is whole-genome sequenced and has applications in enteric disease research.

Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.
