Avian reovirus type 3 strain 59 is propagated in primary chicken embryo fibroblasts. This strain was isolated from the intestine of a chicken with cloacal pasting.

### Growth Conditions

**Host:** Primary Chicken Embryo Fibroblast

**Effects:** CPE; syncytia

**Temperature:** 37°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** Plate cells 24-48 hours prior to infection. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.1). Adsorb 1-2 hours at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

**Incubation:** 2 to 7 days in a humidified 5% CO<sub>2</sub> atmosphere
