Description

Human adenovirus 37 strain GW (76-19026) is propagated in WI-38 cells (ATCC CCL-75). This strain was isolated in 1976 from the eye of a human with keratoconjunctivitis and was deposited by the National Institute for Public Health and the Environment, Netherlands. This product has applications in infectious and respiratory disease research.

Host: WI-38 (ATCC CCL-75) Effects: cell rounding; cell sloughing; CPE Complete medium: EMEM (ATCC 30-2003) + 2% FBS (ATCC 30-2020) Temperature: 37°C Atmosphere: 95% Air, 5% CO₂ Recommendations for infection: Plate cells 24 hours prior to infection and infect when cultures are 75-90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm²) diluted to provide an optimal MOI (e.g. 0.1). Adsorb 1-2 hours at 37°C in a humidified 5% CO₂ atmosphere while rocking continuously. End adsorption by adding virus growth medium. Incubation: Incubate infected culture for 2-11 days at 37°C in a humidified 5% CO₂
