## Description

Human adenovirus 41 strain Tak (73-3544) is propagated in 293 [HEK-293] cells (ATCC CRL-1573). This strain was isolated in 1973 from the feces of a 14-month old human with gastroenteritis and was deposited by the National Institute for Public Health and the Environment, Netherlands. This product is whole-genome sequenced has applications in enteric and infectious disease research.

## Growth Conditions

**Host:** 293 [HEK-293] (ATCC CRL-1573)

**Effects:** cell clustering; cell rounding; cell sloughing; CPE

**Complete medium:**

EMEM (ATCC 30-2003) + 2% FBS (ATCC 30-2020)

**Temperature:** 37°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** Plate cells 24 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.1). Adsorb 1-2 hours at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, rocking every 15 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

**Incubation:** 2-7 days

**Mycoplasma contamination:** Not detected

## Notes

Good immunogen in rabbits. No two-way cross serum neutralization or HA with 37 prototypes. Related to strain Dugan (79-18025) by serum neutralization and HAI. HA at low titer in rat red blood cells. No HA in rhesus monkey or human O type red blood cells.
