## Handling Procedures

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
  2. Rehydrate the entire pellet with approximately 0.5 mL of #416 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #416 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
  3. Use several drops of the primary broth tube to inoculate a #416 plate and/or #416 agar slant.
  4. Incubate at 26°C for 24-48 hours.
