## Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #80 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.

3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well
  4. Use several drops of this suspension to inoculate a second tube of broth, a slant and/or a plate.
  5. Incubate tubes and plate at 26°C in an atmosphere of 5% CO<sub>2</sub> for three to five days. Loosen screw caps of all test tubes during the incubation period.

Colonies on #80 agar are entire, glistening, smooth, and of varying size.
