Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette and use to rehydrate the entire pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
4. Use several drops of this suspension to inoculate an additional broth tube, a #44 agar slant and/or a plate.

5. Incubate the tubes and plate at 37°C 24 hours.

Notes

Colonies on #44 plates are glistening, smooth, translucent, and grayish-green, with an irregular, spreading margin. Two colonial morphologies may be observed. Additional information on this culture is available on the ATCC® web site at www.atcc.org.
