ATCC Medium 18: Trypticase Soy Agar/Broth

**Temperature:** 30°C

### Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #18 agar slant and/or

plate.

5. Incubate all tubes and plate at 30°C for 48 hours.

## Notes

Two colony types are observed on #18 agar: a) 90% entire margins, rough centers; b) 10% entire, blue pigmented with gray margins. Pigment may vary depending to cultural conditions. Crystalline formation seen.
