Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

Frozen ampoules packed in dry ice should either be thawed immediately or

stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampoules at refrigerator freezer temperatures (generally -20°C).** Storage of frozen material at this temperature will result in the death of the culture.

1. To thaw a frozen ampoule, place in a 25°C to 30°C water bath, until just thawed (approximately 5 minutes). Immerse the ampoule just sufficient to cover the frozen material. Do not agitate the ampoule.
2. Immediately after thawing, wipe down ampoule with 70% ethanol and aseptically transfer at least $50\ \mu\text{l}$ (or 2-3 agar cubes) of the content onto a plate or broth with medium recommended.
3. Incubate the inoculum/strain at the temperature and conditions recommended.
4. Inspect for growth of the inoculum/strain regularly. The sign of viability is noticeable typically after 1-2 days of incubation. However, the time necessary for significant growth will vary from strain to strain.

Every effort is made to provide strains having the exact requirements as listed in the catalogue. However, yeast strains, like every other biological system, are constantly undergoing change, so that the sample you receive may not have exactly the same markers as determined when the strains were stored: reversion of certain mutations may have occurred, new mutations or suppressors which impart selective advantage to the strain may have been acquired and there may be ploidy changes. We urge checking the strains before extensive use.

Diploid; high sporulation strains (BK1); SK-1 sporulates constitutively; asci will re-diploidize to give back the SK-1 strain; use fresh, log-phase mitotic

cultures for starting sporulation experiments; occasional sporulation-defective variants arise on plates-these can be avoided by checking single colonies for sporulation ability; use Acetate agar (ATCC MD-2028) for sporulation.
