## Handling Procedures

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #416 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #416 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary

- broth tube to these secondary broth tubes.
3. Use several drops of the primary broth tube to inoculate a #416 plate and/or #416 agar slant.
  4. Incubate at 37°C for 24 hours in an atmosphere of 5% CO<sub>2</sub>.

## Notes

Growth is best in broth culture or on biphasic slants.

Growth on agar may take 48 hours.
