ATCC Medium 172: N-Z amine with soluble starch and glucose

Temperature: 26°C

Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #172 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire

pellet.

3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
4. Use several drops of this suspension to inoculate an additional broth tube, one or two #172 agar slants and/or a plate.
5. Incubate the tubes and plate at 26°C for 7 to 14 days.

Notes

Colonies on #172 agar are orange with an undulate margin becoming pulvinate and then folded or wrinkled with time. Dark brown pigmentation develops as sporulation occurs. Spores are oval and non-motile. Cells exhibit branching hyphae. Aerial mycelia are absent.
