### Handling Procedures

1. Open vial according to enclosed instructions.
- 2. Using a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5**

to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

**3. Aseptically transfer this aliquot back into the broth tube. Mix well.**

**4. Use several drops of the suspension to inoculate a #196 agar slant and/or plate.**

5. Incubate the tubes and plate at 26°C for 7 to 10 days.

## Notes

Aerial mycelia on #196 agar are abundant and white.
