ATCC Medium 527: Inorganic salts starch agar (ISP Medium 4)

Temperature: 26°C

Handling Procedures

1. Open vial according to enclosed instructions.
2. **Using a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
3. **Aseptically transfer this aliquot back into the broth tube. Mix well.**
4. **Use several drops of the suspension to inoculate a #527 agar slant and/or**

plate.

5. Incubate tubes and plates at 26°C, under aerobic conditions, for 14-16 days.

6. After 14-16 days of incubation, wash cells from the slant and transfer this broth to a new slant and plate. Incubate another 14-16 days under aerobic conditions. This second transfer and incubation is necessary for complete removal of the cryoprotectant, which can inhibit growth.

Notes

Aerial mycelia on #527 agar are light grey with white. Substrate growth is light brown.

The cells are 100% rectiflexibles.
