## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #926 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
  5. Incubate all tubes and plate at 30°C for 24 hours.

## Notes

Colonies on #926 plates are entire, smooth, glistening, and low convex. Cells are Gram-negative, motile rods.
