## Handling Procedures

1. Open vial according to enclosed instructions.
  2. **Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
  3. **Aseptically transfer this aliquot back into the broth tube. Mix well.**
  4. **Use several drops of the suspension to inoculate a second tube of broth and a #260 agar slant and/or plate.**
  5. Incubate the tubes and plate at 37°C for 24 to 48 hours.

## Notes

After 24 to 48 hours of incubation, colony morphology on #260 agar is circular, small, smooth, entire, and white. Cell morphology is gram positive cocci that form long chains.

Colonies on #1169 agar are bright pink, small, round smooth, and entire. This medium is recommended by the depositor, but better growth is achieved on #260 agar.
