### Handling Procedures

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Using a single tube of #2 broth (5 to 6 mL), withdraw approximately 0.5 mL to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #2 slant, and/or plate.
  5. Incubate the tubes and plate at the recommended temperature for 24 to 48 hours.
  6. After growth has been achieved, additional transfers may be made or cells prepared for storage. Many *Vibrio* species will die off rapidly only the stationary phase is reached, even at refrigerator temperatures. To avoid frequent transfers, it is recommended that cells be frozen with a suitable cryoprotectant.

Colonies on #2 agar are round, smooth, entire, and large with a creamy texture.
