Handling Procedures

- 1. Open vial according to enclosed instructions.**
- 2. From a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**

3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
 5. Incubate all tubes and plate at 37°C for 24 hours.

Notes

Colonies on #260 plates are pinpoint, smooth, entire, circular, and glistening. It produces weak alpha hemolysis.
