ATCC Medium 172: N-Z amine with soluble starch and glucose

**Temperature:** 26°C

### Handling Procedures

1. Open vial according to enclosed instructions.
- 2. Using a single tube of #172 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
- 4. Use several drops of the suspension to inoculate a #172 agar slant and/or plate.**

5. Incubate the tubes and plate at 26°C for 5 to 7 days.

### Notes

Colonies on #172 agar are slightly irregular, raised, beige and white with a center indentation.
