## Handling Procedures

- 1. Open vial according to enclosed instructions.
  - 2. From a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
  - 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
  - 4. Use several drops of this suspension to inoculate an additional broth tube, a #44 agar slant and/or a plate.
  - 5. Incubate the tubes and plate at 37°C for 24 hours.

## Notes

Colonies on #44 plates are clear, glistening, gray, entire, circular, and smooth. No hemolysis was observed on sheep or rabbit blood agar.
