Handling Procedures

1. Open vial according to enclosed instructions.

2. From a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.

3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.

4. Use several drops of this suspension to inoculate an additional broth tube, a #260 agar slant and/or a plate.

5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

Colonies on #260 plates are entire, glistening, circular, smooth, slightly pinpoint, and translucent.
