Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately

- 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
 5. Incubate all tubes and plate at 26°C for 24 to 48 hours.

Notes

Colonies on #18 plates are flat, undulate, umbonate, and pale yellow to yellow in color; colonies will vary in size. It should be noted that the colonies will change over time, becoming darker in color and with the appearance of black flaks on the surface. In some cases, dark brown spots will appear under areas of heavy growth; this is not a sign of contamination. On blood agar, annular hemolysis will appear around the edges of heavy growth.
