## Handling Procedures

1. Open vial.
2. Rehydrate the entire pellet with approximately 0.5 mL of #12 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #12 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to

these secondary tubes.

3. Use several drops of the primary broth tube to inoculate a #12 plate and/or #12 agar slant.
4. Incubate at 26°C for 3-5 days.
