2. Rehydrate the entire pellet with approximately 0.5 mL of #1 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #1 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
 3. Use several drops of the primary broth tube to inoculate a #1 plate and/or #1 agar slant.
 4. Incubate at 30°C for 24-72 hours.
