### **Handling Procedures**

1. Open vial according to enclosed instructions.
- 2. Using a single tube of #1751 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
- 4. Use several drops of the suspension to inoculate a #1751 agar slant and/or plate.**

5. Incubate the tubes and plate at 18°C for 72 hours.

## Notes

Colonies on #1751 agar plates are size-variable, entire, glistening, circular, smooth, translucent, low convex, and yellow.
