### **Handling Procedures**

- 1. Open the freeze-dried vial according to enclosed instructions.**
- 2. Using a single tube of #196 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.**
- 4. Use several drops of the suspension to inoculate a #196 slant, and/or plate.**

**5. Incubate all tubes and plates at 50°C for 3-7 days.**
