## Growth Conditions

### Medium:

ATCC Medium 0988: Spiroplasma medium SP-4

**Temperature:** 37°C

**Atmosphere:** Aerobic

## Handling Procedures

1. Open thawed vial.
2. Aseptically transfer the entire contents to a 5-6 mL tube of #988 broth.  
Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.

3. Use several drops of the primary broth tube to inoculate a plate and/or agar slant.
  4. Incubate at 37°C for 7-14 days.

## Notes

This strain requires an additional 5% heat-inactivated fetal bovine serum be added to ATCC Medium #988 to sustain growth of this strain. Growth is best achieved in T-25 flask with 10 mL of medium and a 10% inoculum.

Culture does not become turbid. Close observation and fluorescent staining may be necessary to observe cell growth. Incubation time may vary.
