## Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
- 4. Incubate the tube at 37°C for 24 hours.
- 5. After growth has been achieved, use several drops of the suspension to inoculate

an additional broth tube, a #3 agar slant and/or a plate.

#### Notes

On #3 plates, colonies are entire, glistening, circular, smooth, and convex.
