Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions.
- Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a # 18 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37° C for 24 hours.

Notes

On #18 plates, two colony types are observed: a) small, smooth, circular, entire; b) large, smooth, irregular, entire, mucoid.
