ATCC Medium 1859: Nutrient broth or nutrient agar with MnSO₄

Temperature: 30°C

Handling Procedures

- 1. Open the freeze-dried vial according to enclosed instructions.**
- 2. Using a single tube of #1859 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**

3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #1859 slant, and/or plate.
 5. Incubate all tubes and plates at 30°C for 24 to 48 hours.

Notes

Colonies on #1859 agar are low convex, entire, glistening, round, and transparent to opaque, with size variation.
