Handling Procedures

1. Open thawed vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Aseptically transfer the entire contents to a 5-6 mL tube of #2855 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
3. Incubate while shaking at 37°C for 16 hours.
4. Although this item is ideally grown in broth, it will also grow on #2855 agar.

Notes

This strain contains a multi-copy vector encoding a synthetic non-*Aequorea* fluorescent protein. This protein is green in color and can be visualized using flow cytometry and imaging (Excitation: 505 nm; Emission: 525 nm) or a UV box (310 nm). Longer incubations (24-48h) may be required in order to visualize fluorescence. A concentration of 250 µg/mL ampicillin should be maintained at all times during culture.
