Handling Procedures

- 1. Rehydrate vial contents with 0.5 ml of Trypticase Soy Broth.**
- 2. To obtain a biphasic culture, aseptically transfer this aliquot to a #260 slant.**

3. Incubate at 30°C under microaerophilic conditions. Use an anaerobe jar with an active catalyst and a *cCampylobacter* microaerophilic gas generator pack or other acceptable method. Growth is very slow and may take 7 to 10 days.

Notes

Turbidity may not be obvious in the broth portion of the slant. Cells are present at the broth-agar interface. Under phase microscopy the organisms appear as small rods, singly or in short chains. They are non-motile.
