ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submerged in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

1. Open thawed vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Aseptically transfer the entire contents to a 5-6 mL tube of #1705 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.
3. Use several drops of the primary broth tube to inoculate a #1705

plate and/or #1705 agar slant.

4. Or, to obtain a biphasic culture, add several drops of the primary broth tube to a #1705 agar slant. Best practice is to incubate these slants at an angle.
5. Incubate at 37°C under microaerophilic conditions for 2 to 5 days. Use an anaerobe jar with an active catalyst and a microaerophilic gas generator pack or other acceptable method. All tubes and slants should be incubated with caps loosened.

Notes

This is a slow growing organism that requires moist conditions for best growth. Growth in biphasic culture should occur within 2-5 days, but only light turbidity will be seen. To observe growth, examine a wet mount of the broth under phase microscopy. This organism is a medium-size, spiral, motile, Gram negative rod.

The cells do not Gram stain well using traditional procedures. For best results, use a basic fuchsin counterstain in place of the safranin.
