Escherichia coli strain Crooks (ATCC 8739-MINI-PACK) consists of 6 ready-to-use vials of ATCC 8739 frozen in 200 µL of glycerol stock, eliminating the need to rehydrate and culture the strain prior to use. Each vial is provided with a 2-D barcode for easy storage and tracking, as well as peel-off labels for fast and reliable recordkeeping.

ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submerged in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

Frozen mini-cryovials packed in dry ice should either be thawed immediately for use or stored at or below -70°C until the expiration date printed on the label. Storage at -20°C is acceptable for up to 1 year.

1. Thaw the bacterial strain upright using gentle agitation in a 25°C to 30°C water bath. Thawing will be rapid; approximately 2-3 minutes or until all ice crystals have melted.
2. Immediately after thawing, wipe down the mini-cryovial with 70% ethanol and aseptically transfer the entire contents to a 5-6 mL tube of #3 broth or directly inoculate a #3 plate and/or #3 agar slant.
3. Discard the empty vial. Do not refreeze any unused portion as it will result in a loss of viability.
4. Incubate at 37°C for 24 hours.

Notes

Two colony types exist on #3 agar.

Customers must use Nutrient broth to initiate this culture rather than Tryptic Soy. This strain does not grow on TSB (although many other *E. coli* will). The medium used successfully in our labs is Becton Dickinson Nutrient Broth (catalog number 234000) and Nutrient Agar (catalog number 213000).
