Handling Procedures

1. Open vial according to enclosed instructions.
 2. From a single tube of #13 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
 4. Use several drops of this suspension to inoculate an additional broth tube, a #13 agar slant and/or a plate. However, it may be advisable to allow initial growth to occur in broth before transferring to solid medium.
 5. Incubate the tubes and plate at 26°C for 5 to six days.

Notes

Strain does not grow well on agar when first opened. Colonies are pinpoint, entire, glistening, and smooth.
