Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to

- 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
 4. Use several drops of this suspension to inoculate a #260 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 24-48 hours.

Notes

Growth is evident by good turbidity. On #260 plates, colonies are small, clear, circular, convex colonies with slight alpha-hemolysis under heavy growth.
