Aseptically add 0.3 to 0.4 mL of liquid medium to the freeze-dried pellet and

mix well. Transfer 100 μ L to a test tube containing 5 mL LB+50mg/mL of ampicillin. A loopful of culture can also be streaked on an LB + amp agar plate. Incubate cultures at 37⁰ C. Isolate DNA using standard plasmid preparation procedures.

Restriction digests of the clone gave the following bands (in kb) : EcoRI 3.0, 1.4 ; PstI 3.1, 1.2 ; EcoRV 4.0, 0.2. ----ATCC staff
