Handling Procedures

- 1. Open vial according to enclosed instructions.
 - 2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
 - 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 - 4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
 - 5. Incubate the tubes and plate at 37°C for 24 hours.
- 1. Open vial according to enclosed instructions.
 - 2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
 - 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 - 4. Use several drops of the suspension to inoculate additional #3 broth tubes, agar slant, and/or plate.

Notes

Colonies on #3 agar are circular, entire, glistening, low convex, smooth and translucent. Cell morphology is gram negative rods that are motile.

On #3 plates, colonies are entire, glistening, smooth, translucent, and gray.
