Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #416 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the

- entire pellet.
3. Use 0.1 ml of this suspension to inoculate #416 slants and 0.1ml to inoculate #416 plates.
 4. Incubate tubes and plates at 30°C, under aerobic conditions, for 48 hours.
 5. After 48 hours of incubation, wash cells from the slant and transfer this broth to a new slant and plate. Incubate another 48 hours under aerobic conditions. This second transfer and incubation is necessary for complete removal of the cryoprotectant, which can inhibit growth.

Notes

Growth on agar at 48 hours yields convex colonies, approximately 2 mm in diameter, with entire margins and a cream-colored hue.

Cells are Gram positive, nonmotile, irregular rods, occurring in pairs and chains predominantly.
