*Escherichia coli* strain 2000-3039 is a whole-genome sequenced strain that was isolated from stool in Maine. It is toxigenic and was confirmed by PCR to carry the *eae* and *stx1* genes. It has applications in food testing, enteric disease research, and infectious disease research.

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately

- 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
  5. Incubate the tubes and plate at 37°C for 24 hours.

### Notes

This strain was confirmed by PCR to carry the *eae* and *stx1* genes (*stx1+*, *stx2-*, *eae+*).
