



Escherichia coli (Migula) Castellani and Chalmers

Description

Escherichia coli strain 2002-3211 is a whole-genome sequenced strain that was isolated in Virginia from stool. It is toxigenic and is positive for the *eae* and *stx2* genes and negative for the *stx1* gene. This strain is serotype O121:H19 and has applications in enteric disease research and food testing.

Handling Procedures

1. Open vial according to enclosed instructions.
 2. Using a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
 4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.
 5. Incubate the tubes and plate at 37°C for 24 hours.
