Handling Procedures

1. Open thawed vial.
2. Aseptically transfer the entire contents to a 5-6 mL tube of #2 broth.
Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #2 plate and/or #2

agar slant.

4. Incubate at 26°C for 2-3 days.

Notes

Colonies on #2 agar are circular, entire, low convex, dry, vary in size, and become embedded in the agar.
