Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

<u>Frozen vials should either be thawed immediately or stored in liquid nitrogen</u>. If liquid nitrogen storage facilities are not available, frozen vials may be stored at or below -70°C. **Do not under any circumstance store frozen vials at refrigerator freezer temperatures (generally -20°C) for long-term storage.** Long-term storage of frozen material at this temperature will result in the death of the culture.

- 1. To thaw a frozen vial, place it at room temperature or in 30°C water bath (not submerged), until just thawed (around 90 seconds).
- 2. Immediately after thawing, aseptically transfer the culture into a test tube or plate with medium recommended.
- 3. Incubate the test tube or plate at the temperature recommended (25-28°C).
