Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

Handling Procedures

Frozen ampoules packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampoules at refrigerator freezer temperatures (generally -20°C).** Storage of frozen material at this temperature will result in the

death of the culture.

1. To thaw a frozen ampoule, place in a **25°C to 30°C** water bath, until just thawed (**approximately 5 minutes**). Immerse the ampoule just sufficient to cover the frozen material. Do not agitate the ampoule.
2. Immediately after thawing, wipe down ampoule with 70% ethanol and aseptically transfer at least 50 µL (or 2-3 agar cubes) of the content onto a plate or broth with medium recommended.
3. Incubate the inoculum/strain at the temperature and conditions recommended.
4. Inspect for growth of the inoculum/strain regularly for up to 4 weeks. The time necessary for significant growth will vary from strain to strain.

Notes

Phytophthora are commonly called water molds and grow in moist or wet medium. In our labs we have found that it is best to transfer the entire thawed material into a small volume (approximately 5.0 mL) of Yeast Mold broth containing trace amount of biotin and thiamine (ATCC Medium 2232) and incubate at the recommended temperature until signs of growth are visible before transfer to a few plates of fresh, moist agar medium. Agar plates are used for examining characteristics of the strain but are not necessarily the best recovery media for cryopreserved cultures. It is also important that the agar be kept moist so wrapping the plates in parafilm and adding a bit of broth to the plates during incubation is helpful.
