Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

Handling Procedures

Frozen ampoules packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampoules at refrigerator freezer temperatures**

(generally -20°C). Storage of frozen material at this temperature will result in the death of the culture.

1. To thaw a frozen ampoule, place in a **25°C to 30°C** water bath, until just thawed (**approximately 5 minutes**). Immerse the ampoule just sufficient to cover the frozen material. Do not agitate the ampoule.
2. Immediately after thawing, wipe down ampoule with 70% ethanol and aseptically transfer at least 50 µL (or 2-3 agar cubes) of the content onto a plate or broth with medium recommended.
3. Incubate the inoculum/strain at the temperature and conditions recommended. Inspect for growth of the inoculum/strain regularly. The sign of viability is noticeable typically after 2-4 days of incubation. However, the time necessary for significant growth will vary from strain to strain.

Morphology: On potato dextrose agar after 13 days at 25°C, mycelium white to creamy white. Sclerotia abundant, ranging in color from white, yellow, orange, red. Conidiophores white to creamy white. Sclerotia subglobose to broadly ellipsoidal. Conidiophore stipes brownish orange, up to 1950µm long and 15µm wide, walls rough; vesicles globose to subglobose, thick walled, 36-39 µm X 31.5-39 µm; metulae 10.5-13.5 µm X 2.4-5.25 µm; phialides 6-9 µm X 4.5 µm; conidia globose, 3-3.75 µm X 3 µm.
