will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Medium:

ATCC Medium 2348: Freshwater Diplophrys medium

Temperature: 21°C

Incubation: grown with Klebsiella pneumoniae ATCC 700831and mixed bacteria

Handling Procedures

Frozen ampules packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampules at refrigerator freezer temperatures (generally -20°C).** Storage of frozen material at this temperature will result in the death of the culture.

1. To thaw a frozen ampule, place it in a 35°C water bath such that the lip of the ampule remains above the water line. Thawing time is approximately 2 to 3 minutes.

Do not agitate the ampule. Do not leave ampule in water bath after it is thawed.

- 2. Add the thawed contents to a T-25 flask containing 10 ml of ATCC media 802 and 2348, combined 1:2 and bacterized with *Klebsiella pneumoniae* subsp. *pneumoniae* (ATCC® 700831) or *Enterobacter aerogenes* (ATCC® 13048).
- 3. Incubate with the cap tightly sealed at 25°C.

Culture maintenance:

Subculture every two weeks to a fresh T-25 flask of bacterized medium in the following manner:

- 1. Vigorously agitate the flask (or scrape the flask bottom using a sterile cell scraper) and aseptically transfer 0.5 ml from a growing culture to a T-25 tissue culture flask containing 10.0 ml of ATCC media 802 and 2348, combined 1:2 and bacterized with *Klebsiella pneumoniae* subsp. *pneumoniae* (ATCC® 700831) or *Enterobacter aerogenes* (ATCC® 13048).
- 2. Incubate flask at 25°C with the cap on tightly.
