## **Description**

**Antigenic Properties:** Serotype 23 (Danish designation 23F)

**Product Description:** Purified pneumococcal polysaccharide type 23F is manufactured by Pfizer, Inc. for small quantity distribution by ATCC. The pneumococcal powder type 23F is a component of the current 13-valent vaccine against *Streptococcus pneumoniae*.

The pneumococcal polysaccharide type 23F can be used to assay for type-specific antibodies, research immune responses and study immunodeficiencies.

## **Propagation**

### **Method for Resuspension**

1. Prepare a 2 mg/mL pneumococcal polysaccharide stock solution by adding 1 mL of pyrogen-free distilled water to 2 mg of pneumococcal polysaccharide.
2. Incubate the suspension overnight at 2-8°C with gentle stirring on a stir plate to dissolve the polysaccharide.
3. Aliquot the polysaccharide solution and store the aliquots containing the stock solution at -60°C to -80°C.

## **Notes**

Stock solution can be diluted to a working concentration in the buffer of the researcher's choice.

Storage of Powder: Store at -20°C or colder.

Storage of Reconstituted Material: Store at -60°C to -80°C.
