Propagation Procedure

1. Open vial according to enclosed instructions.
2. **Using a single tube of #33 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.**
3. **Aseptically transfer this aliquot back into the broth tube. Mix well.**
4. **Use several drops of the suspension to inoculate a #33 agar slant and/or plate.**
5. Incubate the tubes and plate at 26°C for 24 hours.

Notes

Colonies on #33 agar are small, round, convex, entire and mucoid.
