### Medium

ATCC® Medium 3: Nutrient agar or nutrient broth

### Growth Conditions

**Temperature:** 30°C

**Atmosphere:** Aerobic

### Propagation Procedure

1. Open vial according to enclosed instructions.
2. From a single tube of #18 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette and use to rehydrate the entire pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
4. Use several drops of this suspension to inoculate a second tube of broth, a slant, and/or a plate.
5. Incubate all tubes and plate at 30°C for 24 hours.

## Notes

On #18 plates, two colony types may be observed: a) round, opaque, convex, rough, and entire becoming flat with age; b) round, flat, opaque, erose, and very rough with a translucent spreading margin.
