## Propagation

### Medium

ATCC® Medium 416: Lactobacilli MRS Agar/Broth

### Growth Conditions

**Temperature:** 37.0°C

### Propagation Procedure

1. Open vial according to enclosed instructions.
2. From a single tube of #416 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well
4. Use several drops of this suspension to inoculate a second tube of broth, a slant and/or a plate.
5. Incubate tubes and plate at 37°C for 24 to 48 hours. Plates will take longer for colonies to appear.

## Notes

Colonies on #416 plates appear flat, erose, and translucent to opaque, with a sticky consistency and dull sheen.
