Propagation Procedure

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

Colonies on #3 agar plates are entire, glistening, circular, smooth, translucent, and low convex. This strain produces black colonies on XLD Medium.

Reported to have the following antigenic properties: 47:i:z₅₃:(z₅₇) Ar. 23:33-25.
